O R D E R

The petitioner Sri Abhijit Sharma is absent. One Sri Rajib Deka appeared on his behalf. The public authority is represented by :- (1) Sri Ananua Ch. Karmakar, SPIO and Joint Director of Agriculture (PD), Khanapara, D.A Division, Guwahati, and (2) Sri Palashmoni Baruah, SDAO (Surveillance) , Khanapara, DA .

The second appeal petition dated 3-9-2014 is taken up for consideration in presence of both the parties.

It is seen from the case records that the petitioner Sri Abhijit Sharma filed an RTI petition dated 28-4-2014 before the Director of Agriculture, Govt. of Assam, seeking information about an inquiry against "BGREI" scheme. The petitioner mentioned in his RTI application that he came to know about an inquiry , as per his information. He did not specify as to who ordered the inquiry and in what context, although some specification about the information sought for is required under Section 6 (1) of the RTI.

This Commission, therefore, directs the petitioner to give some specification about the information sought for and its source, like, news paper reports, T.V news etc. from where he came to know of any such inquiry, to the SPIO of the Director of Agriculture, within 15 days from the date of receipt of this order and the SPIO is directed to furnish the required information within another 15 days from the date of receipt of the information from the petitioner.

With the above order, the second appeal petition dated 3-9-2014 is disposed of.
