## ORDER

The petitioner Sri Mithuram Doley is present. He is accompanied by one Sri Ramesh Doley. The public authority to be represented by the PIO of the office of the Principal Secretary, Mising Autonomous Council is absent. However, he has sent a written submission dated 29-6-2016, authorizing Sri Rajiv Doley, Dealing Assistant, RTI branch of the Autonomous Council. The Commission allows Sri Rajiv Deley , LDA to represent Mising Autonomous Council during todays' hearing , taking into account the long distance that he had to travel, with a direction to the Principal Secretary, Mising Autonomous Council that in future either the Principal Secretary himself , or his PIO or any other officer conversant with the RTI cases shall be deputed to appear before this Commission.

The re-submitted appeal petition dated 23.5-2016 is taken up for consideration in presence of both the parties.

In his written statement , the PIO of Mising Autonomous Council stated that the sought for information , i.e., the minutes of the meeting of the Departmental Purchase Committee of Mising Autonomous Council held on 24-12-2015 and the corresponding comparative statement could not be furnished earlier, as the same were not finalized. After finalization of the minutes of the meeting and the comparative statement, copy of these documents have been furnished with the written submission. This Commission gave the enclosures , i.e., the minutes of the Departmental Purchase Committee held on 24-12-2015 along with the comparative statement to the petitioner/ appellant for his further necessary action.

In course of hearing the petitioner also wanted to know from the representative of the Mising Autonomous Council whether supply orders have been placed on the basis of the finalized minutes and comparative statement. The representative of Mising Autonomous Council submitted that he is not aware of any development in this regard.

This Commission, therefore, directs the Principal Secretary, Mising Autonomous Council to inform the petitioner about the present position in this regard within 7 days from the date of receipt of this order.

With the above order, the re-submitted second appeal petition dated 23-5-2016 is disposed of.
