**O R D E R**

The petitioner Sri Keshab Chandra Bhuyan is present He is accompanied by Sri Mrinmoy Dutta, Advocate. The public authority is represented by :- (1) Sri Pabitra Khound, ACS, Joint Secretary, Health & F.W Department, (2) Sri Mrinal Dutta, Sr. Administrative Asstt., (3) Dr. Rajeeb Kr. Sharma, Addl. DHS, & SPIO, (4) Sri Padma Ram Das, V.D. Asstt, and (5) Sri Bijoy Sarma, Jr. Asstt.

The second appeal petition dated 7-5-2016 is taken up for hearing in presence of both the parties.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 2-9-2015 before the SPIO of the office of Commissioner & Secretary, Govt. of Assam, Health & F.W (A) Department. He sought information regarding payment of his outstanding bill amounting to Rs. 3,71,447/-. In his RTI petition he mentioned that necessary proposals were sent by the Directorate of Health Services to the Commissioner & Secretary Health & F.W Department.

The SPIO of Health & FW Department submitted that they have received the proposal from the Directorate of Health Services, Govt. of Assam. The proposal of DHS is pending for according sanction.

The SPIO further mentioned that interest will be payable from 20-5-2005 till the date of sanction. The petitioner also stated that he is agreeable to this suggestion of the SPIO.

In view of the above, this Commission directs the SPIO of Health and Family Welfare Department to inform the petitioner about the up-to-date position with regard to the pending claim of the petitioner within 30 days from the date of receipt of this order.

Within the same period the SPIO will also furnish attested copies of the correspondences made between the DHS and the Health Department, Govt. of Assam in this regard.

With the above direction the second appeal petition dated 7-5-2016 is disposed of.
