# <u>ORDER</u>

The petitioner Smti Padumi Barman is present along with her husband Sri Atul Ch. Barman. The public authority is represented by :- (1) Dr. Bhupen Talukdar, AES, SPIO and Joint Director of Secondary Education, Assam.

The second appeal petition dated 25-10-2013 is taken up for further hearing in pursuance of this Commission's earlier order dated 28-11-2013.

From perusal of the case records, it is seen that the second appeal petition was already heard by the then State Information Commissioner Sri M. C. Malakar and order was passed on 28-11-2013. By that order the SPIO of the Directorate of Secondary Education was directed to furnish the following documents to the petitioner within 20 days from the date of receipt of that order :-

(a) Copy of the transfer order of Smti Garima Sarma, and

(b) Copy of the speaking order of the hearing held by the Director of Secondary Education on 12-4-2012.

The petitioner submitted that she has in the meanwhile received copy of transfer

order of Smti Garima Sarma but she is yet to receive copy of the order of the hearing held by the Director, Secondary Education on 12-4-2012.

This Commission directs the SPIO of the Directorate of Secondary Education to furnish a copy of the speaking order dated 12-4-2012 of the Director of Secondary Education to the petitioner within 15 days from the date of receipt of this order.

With the above order the second appeal petition dated 28-11-2013 is disposed of.
