O R D E R

The petitioner/ appellant Sri Satyendra Sarma is represented by his Advocate Sri Seuj Bikash as authorized by the petitioner. . The public authority is represented by :- (1) Sri Arup Hazarika, Chief Executive Officer, Rangiya Electrical Circle , APDCL, (2) Sri Sachin Das, SPIO of the office of the Chief Executive Officer, Rangiya Electrical Circle , APDCL, and (3) Sri Krishna Sarma, SPIO/ DGM, office of the CGM (D) APDCL (LAR), Bijulee Bhawan , Paltanbazar, Guwahati-1

The second appeal petition dated 4-3-2015 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 12-12-2014 before the PIO of the office of the Chief Executive Officer, Rangiya Electrical Circle, LAR, APDCL.

It is seen from the case records that no information has been furnished to the petitioner till date, even after filing of first appeal petition dated 20-1-2015 and second appeal petition dated 4-3-2015

From perusal of the RTI petition dated 12-12-2014 it appears that the petitioner has not been able to clearly and specifically describe the information he wanted. However, when asked by this Commission, his representative Advocate Sri Seuj Bikash clarified that he will be satisfied if the following information is furnished :-

- (a) **candidates bearing Roll Nos. REC.00212, REC-00147, REC-00144, REC-00227, REC-00109, REC-00164, REC-00187**
- (b) **Their Wage payment records at least for a period of 3 years before appointment as Sahayak**
- (c) **Their dates of initial engagement on daily wage till regular appointment as Sahayak**

(d) Copies of experience certificates issued in their favour by the concerned competent authority.

This Commission, therefore, directs the CEO, Rangiya Electrical Circle, LAR, APDCL to provide the above informations to the petitioner within 20 days from the date of receipt of this order.

With the above order the second appeal petition dated 4-3-2015 is disposed of.
