**O R D E R**  
13.07.2016

The petitioner Shri Indra Rongphar is absent but has informed that he has not received the information sought for from the Addl. Chief Engineer, PWD (R & B), Hills, Diphu against his RTI petition dated 27.11.2013.

The public authority is absent without any intimation.

In view of large number of cases pending before the Commission, the matter is taken up for consideration, based on records in the absence of both the parties.

On perusal of case records, it appears that due to non-receipt of information on his RTI petition dated 27.11.2013, the petitioner had filed an appeal petition on 07.02.2014 before the Addl. Chief Engineer, (R & B), Hills, Diphu. The SPIO, office of the Addl. Chief Engineer, Diphu vide letter dated 04.03.2014 furnished Annual Action Plan under HADP for the year 2010-11, 2011-12 and 2012-13 and had informed that the reports under HADP for the year 2013-14 may be collected from the concerned Roads Division.

The petitioner on 01.04.2014 filed a Complaint petition before this Commission that the SPIO office of the Addl. Chief Engineer, PWD (R & B), Hills, Diphu had furnished Annual Action Plan under HADP only and no information on Annual Action Plan under State Plan is furnished to him. He also stated that instead of calling him for hearing against his First Appeal, the SPIO and the First Appellate Authority provided him incomplete information.

In view of the above, the Commission remands the First Appeal petition dated 07.02.2014 to the First Appellate Authority for hearing and disposal of the same with a speaking order, within 30 days from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 01.04.2014 is hereby disposed of.
