The petitioner Sri Jawahorlal Narzary is absent without any intimation.

The public authority is represented by Sri Binod Ch. Deka, Addl. Chief Engineer, PHE, KAAC, Diphu accompanied by Sri Bimal Ch. Sarmah, Asstt. Executive Engineer, KAAC, Diphu.

The SPIO, office of the Addl. Chief Engineer, PHE has submitted a written statement dated 06.07.2016 that on receipt of the RTI petition the matter was transferred to four divisions, namely, Hamren Division, Howraghat Division, Diphu Urban W/S Division and Diphu Rural Division vide letter dated 03.09.2014 directing the division to furnish the required information within 10 days. He has stated that the petitioner was furnished information by the SPIO Cum Asstt. Executive Engineer, Urban W/S Division, Diphu vide letter dated 21.10.2014 and the same was resubmitted to the petitioner on 23.02.2015.

The SPIO cum Asstt. Executive Engineer, office of AEE, PHE, Diphu (R) vide letter dated 06.08.2014 had furnished the information to the petitioner which was again communicated to the petitioner vide letter dated 06.07.2016.

The SPIO, Office of the Executive Engineer, Howraghat Division vide letter dated 11.07.2016 furnished the information to the petitioner. A copy of the same was furnished to the Commission.

The Public authority present stated that all the four Sub-Division had furnished the relevant information to the petitioner. In view of the absence of the petitioner, it could not be ascertained whether he received the information and whether he was satisfied with the information furnished. In case the petitioner is not satisfied, he will take up the matter with the Addl. Chief Engineer, PHE, KAAC, Diphu within 10 days from the date of receipt of this order who in turn will take steps to furnish the information within 15 days from the receipt of such communication from the petitioner.

With the above direction, the Second Appeal petition dated 18.02.2015 is disposed of.
