The petitioner Sri Indra Rongphar is absent but has sent an intimation stating his inability to attend the hearing and that information sought for vide his RTI petition dated 27.12.2013 had not been furnished to him.

The Principal Secretary, Karbi Anglong Autonomous Council (KAAC) has submitted a Written Statement dated 27.06.2016 that the RTI petition filed by Sri Indra Rongphar had been forwarded to the Inspector of Schools, Karbi Anglong District Circle, Diphu vide their office letter dated 08.01.2014 to furnish the information to the petitioner and that the First Appeal petition referred to had not been received by the office and hence, not disposed of. He also marked a copy of the letter sent to the Inspector of Schools, Karbi Anglong referring to the Appeal petition and the Commission's notice dated 14.06.2016 for disposal. Seen the letter no. AC/Branch/RTI/2013/24 dated 27.06.2016 from the Inspector of Schools, Karbi Anglong addressed to the Commission wherein he has stated that he had submitted the replies on the Appeal petition dated 21.04.2014 with copy to Sri Indra Rongphar.

However, it could not be ascertained whether the replies sent to the Commission had been furnished to the petitioner, therefore, the Inspector of Schools, Karbi Anglong Autonomous Council is directed to furnish the copies of the reply to the appellant which was furnished to the Commission, if not furnished, within 1 (one) week from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 21.04.2014 stands disposed of.
