Shri Ranjit Hazarika, SPIO/Jt. Secy., Higher Education (Tech.) Department, Govt. of Assam is present with an assistant. A Written Statement dated 26.07.2016 received from the SPIO which is taken on the case record.

The Complainant/Appellant present.

Heard the Complainant/Appellant. He submitted that he was yet to receive the information, and that he received no response to his First Appeal dated 27.12.2014. He however added that he had received a letter dated 10.12.2014 providing information with reference to his earlier RTI Application dated 31.10.2014 and instant RTI Application dated 13.11.2014, and stated that the information provided therein did not relate to his Application dated 13.11.2014. He further requested in writing that as he was still interested in getting the information his Complaint case be treated as an Appeal.

Perused the Written Statement. It has been submitted that information had been provided to him twice, first after receiving the RTI Application and then in response to the First Appeal. It is seen that the information provided was not specifically related to the information sought through the Application dated 13.11.2014.

Heard the SPIO. He submitted that a revised letter can be issued addressing the specific information that the Appellant had sought.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the Higher Education (Tech.) Department, Govt. of Assam shall provide the information sought for by the Appellant through his RTI Application dated 13.11.2014, free of cost, within 10 days of receipt of this order.

With this, the Appeal Petition is disposed of.
