The Complainant/Appellant present.

The SPIO absent without information.

Perused the case record. It is seen that through his RTI Application the Complainant had sought a copy of the voters list in respect of village Milanpur in South Salmara Police Station of South Salmara Mankachar Sub-Division as on 01.01.1985/01.01.1986 in which the name of the aforementioned lady of the said village could be enlisted.

Heard the Complainant/Appellant. He submitted that subsequent to filing of his Complaint dated 07.04.2015 he received a letter dated HEL-46/2014/23 dated 18.05.2015 through which he had been informed that there was no village by the name of Milanpur in the area of South Salmara Police Station per voters list of 1985-86. However, the reply does not mention as to whether the name of Smti. Suchitra Sarkar, daughter of Shri Mina Ram Sarkar figures in the voters list of any other village in the said Police Station area. As an evidence that there was indeed a village called Milanpur, the Appellant submitted a copy of a school certificate although the certificate did not pertain to the person named by him.

He further requested in writing that as he was still interested in getting the information his Complaint case may be treated as an Appeal.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the SDO (C), Hatsingimari shall ascertain as to whether the name of the said lady, namely Smti. Suchitra Sarkar figures in the voters list of any other village under South Salmara Police Station, and provide the information to the Appellant, within 15 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
