<u>ORDER</u>

The petitioner Shri Kamlesh Kamat is absent without information. The public authority is represented by:- (1) Shri Gobinda Ch. Kalita, Superintendent & SPIO of the Directorate of Food, Civil supplies & CA (FCS&CA), Assam, and (2) Shri Gunadhar Gayan, Sr. Asstt. of the Directorate of FCS&CA, Assam. The second appeal petition dtd 17.1.14 is taken up for hearing ex-parte in absence of the petitioner.

The SPIO in the Directorate of FCS&CA has submitted a written statement dtd 12.7.16 stating that the information sought for by Shri Kamlesh Kamat vide his RTI petition dtd 17.10.13 was already furnished to him vide Directorate's letter dtd 18.10.13. Copy of that letter and information furnished have been enclosed with the WS. The SPIO of the Directorate has also enclosed copy of the order dtd 7.11.14 passed by the FAA disposing of the first appeal petition dtd 27.11.13.

This Commission has observed that the same petitioner Shri Kamlesh Kamat has filed several RTI petitions relating to FCS&CA Department followed by subsequent first and second appeal petitions. But the petitioner has never appeared before this Commission at the time of hearing of his second appeal petitions. It becomes difficult for this Commission to deliberate upon his second appeal petitions in his absence.

As for the instant second appeal petition dtd 17.1.14, it is disposed of in view of the fact that the SPIO of the Directorate of FCS&CA Department had already furnished the required information to the petitioner.
