O R D E R

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by:- (1) Sri D. Upadhaya, IPS, DCP (A), Guwahati, (2) Sri Upendra Nath Goswami, APS, Deputy Superintendent, Assam Police Headquarters, Ulubari, Guwahati-7 (3) Sri Paresh Bora, ASI, Assam Police Headquarters, and (4) Sri Sujit Deb, ASI of Police, Office of the Commissioner of Police, Guwahati.

The second appeal petition dated 27-1-2014 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that the information sought for by Sri Dulal Bora vide his RTI petition dated 3-10-2013, addressed to the DGP, Assam has not been furnished till date. The AIGP (A) and PIO has submitted a written statement dated 27-5-2016 stating that the petitioner's RTI petition dated 3-10-2013 was transferred on 10-10-2013 to the then Senior Superintendent of Police, Guwahati vide Memo No. G(RTI)/VI/237/2013/2 dated 10-10-2013. The petitioner vide his RTI petition dated 3-10-2013 and 12-6-11 sought information about untoward incidents in Guwahati city in connection with the agitational programmes undertaken by the Krishak Mukti Sangram Samitee.

This Commission, therefore, directs the SPIO of the present Commissioner of Police, Guwahati City to furnish the required information to the petitioner within 15 days from the date of receipt of this order.

Therefore, the second appeal petition is disposed of.
