The petitioner Sri Harinarayan Pathak is present.

The Public Authority is represented by Sri Ghana Pegu, SPIO & i/c Addl. Registrar of Co-operative Societies (Gen), office of the Registrar of Co-operative Societies, Assam assisted by Sri Rakesh Hazarika, Dealing Assistant.

The SPIO and Addl. Registrar of Co-operative Societies has submitted a written statement dated 21.07.2016 that the RTI application of Sri Harinarayan Pathak dated 07.04.2014 was transferred to the Joint Registrar of Cooperative Societies, Khanapara vide letter dated 08.04.2014. As the society was registered under the office of the Asstt. Registrar of Cooperative Societies, Kamrup, the RTI application was transferred to the Asstt. Registrar of Cooperative Societies, Bhangagarh vide letter dated 21.05.2014 to furnish the information to the petitioner directly.

The SPIO present also furnished a copy of the letter submitted by the Joint Registrar of Cooperative Societies (Gen.) enclosing a copy of the registration certificate dated 18.07.2016 which was received by the petitioner during the hearing. The petitioner however objected that he had not received copies of the public documents as received by the office of the Registrar of Cooperative Societies, Assam for issuing of the public document as mentioned in the point no.1 of the RTI petition. He has also stated that copy of the Bye-law approved by the office of the Registrar of Cooperative Societies, Assam in respect of the society M/s Purbattar Udyog Handicrafts Societies Ltd. was also not furnished.

The Public Authority present stated that these documents are available in the office of the Asstt. Registrar of Cooperative Societies and they will collect the information from the office of the Asstt. Registrar of Cooperative Societies and furnish the same to the petitioner within 1 week from the date of receipt of this order.

In view of the above, the Commission directs the SPIO, office of the Addl. Registrar of Co-operative Societies to furnish the information to the petitioner within 7 days from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 08.09.2014 is disposed of.
