The petitioner Miss Rumali Basumatary is absent without information.

The Public Authority is represented by Sri. Hema Ch. Saikia, Deputy Director, Sanskrit Education cum Secretary, ASB, Kahilipara accompanied by Sri. Dwijendra Nath Sarma, office of the Deputy Director Higher Education.

The Secretary, Assam Sanskrit Board has submitted a written statement dated 13.07.2016 that due to absence of some essential information in the petition, information sought for by the petitioner could not be furnished. The Deputy Director cum Secretary, ASB present stated that approximately 16 thousand students appeared for examination conducted by the Sanskrit Board and in the current year around 23 thousand students has appeared for the examination. In view of absence of at least the name and address of the school from where Miss Pramila Roy had appeared for the examination, it would be difficult to furnish the information sought for, as there may be many Pramila Roy appearing in the examination from various centres.

The Commission observes that the petitioner is no longer interested to obtain the information sought for as she is absent without any intimation. However, the Commission directs the petitioner to furnish the name and address of the school from which Miss Pramila Roy had appeared for examination within 7 days from the date of receipt of this order to the Deputy Director cum Secretary, Assam Sanskrit Board who in turn will furnish the information on receipt of details within 15 days from the date of receipt of this order.

With the above direction, the petition dated 23.02.2016 is disposed of.
