The petitioner Sri Joshim Uddin Laskar is absent.

The Principal, Matijuri Higher Secondary School, Hailakandi has submitted a written statement dated 18.07.2016 that he take over Unilateral Charge of Principal of Matijuri Higher Secondary School as per the order of Inspector of Schools, Hailakandi dated 23.06.2016 and till date Mr. Alim Uddin Barbhuiya, Ex- Principal i/c of the school has neither handed over charge nor and any documents of the school. He has stated that Mr. Alim Uddin Barbhuiya was the Principal i/c till 22.06.2016 and he is not aware why he has not submitted the compliance report of order dated 04.03.2016, remained absent from the hearing and not furnished the information to the applicant. As he has not received the charge of the Principal of the school, he is not in a position to furnish any information at present and will be able to furnish the information to the petitioner only on receipt of documents and files of the school.

The Commission therefore directs (i) the present Principal i/c, Md. Nazrul Islam Barbhuiya to furnish the information sought for by the petitioner within 21 days from the date of receipt of this order; and (ii) the First Appellate Authority *i.e.* the Inspector of Schools, Hailakandi District Circle shall hear and dispose the First Appeal dated 07.02.2014 with a peaking order within 30 days from the date of receipt of this order.

With the above direction, the Second Appeal petition 28.04.2014 is disposed.
