The Appellant present along with an assistant. A Written Statement dated 05.08.2016 received from him which is taken on the case record.

The SPIO present along with an assistant. A Written Statement dated 26.07.2016 is received from the First Appellate Authority/S.D.O. (C), Bajali which taken on the case record.

Perused the W/S from the Appellant and heard him in person. It has been submitted that he had not received the copy of a certain letter regarding acquisition of land which he had sought through his RTI Application dated 28.01.2016. He has appealed for the needful so he can receive the copy of the said document.

Perused the W/S and heard the SPIO. It has been submitted that the concerned letter was the letter issued by D.C., Barpeta, and that a copy of the same has been sought from the D.C.'s office through a letter dated 24.05.2016. It has also been submitted that the FAA had issued an order dated 24.05.2016 to the effect that the said documents be obtained from the D.C., Barpeta. The SPIO submitted that an effort would be made to obtain a copy of the said document by deputing an official.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall provide a copy of the aforementioned document after obtaining the same from the office of the D.C., Barpeta, free of cost, within 15 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
