<u>O R D E R</u> 05.08.2016

The Appellant present along with an assistant.

The SPIO/Jt. Director (MCH), Health Services, Assam is present along with an assistant. A Written Statement dated 21.07.2016 received from the SPIO which is taken on the case record.

Heard the Appellant. He submitted that he has received some information with regard to his RTI Application dated 07.11.2015 but found that information relating to query no. 3 in the Application was in accordance with his Application and that information relating to query no. 1 and 2 which are essentially the same was not appropriate.

Perused the case record. It is seen that through query no. 1 and 2 in the Application, the Appellant had sought information/documents relating to the procedure for appointment of ANM staff.

Perused the W/S and heard the SPIO and her assistant. They submitted that they could not locate the relevant rules copies of which have been sought by the Appellant. They however stated that the matter would be discussed with the counterpart SPIO in the office of the DHS, Assam with a view to ascertain the appropriate rules in this connection.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall collect the relevant rules pertaining to query no. 1 and 2 as sought for by the Appellant including from the office of the DHS, Assam as necessary and provide the same to the Appellant, free of cost, within 21 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
