<u>O R D E R</u> 04.08.2016

The Appellant present.

The SPIO absent. However, a Written Statement dated 01.08.2016 received from the CDPO.

Heard the Appellant. He submitted that he has received neither the information he had sought for nor any response from the SPIO as also response to his First Appeal dated 11.12.2013 from the First Appellate Authority.

Perused the W/S. It has been submitted that on receipt of the RTI Application on 11.11.2013, the CDPO had transferred it to the three concerned Anganwadi Centres. The AWCs wrote to the Appellant by registered post, requesting him to deposit certain amount as cost of photocopying documents to be supplied to him. It is further stated that the Appellant submitted the First Appeal instead of depositing the cost of photocopying.

Heard the Appellant again. He submitted that he had not received any communication claimed to have been made by the SPIO/CDPO and that he would have paid the cost if he had received the demand for deposit.

In view of the facts brought out above, the Commission hereby orders as follows.

The SPIO shall once again send to the Appellant within 10 days of receipt of this order, a copy of the letter previously written to him seeking deposit of the cost of photocopying, and within 10 days of receipt of the said demand, the Appellant shall deposit the amount with the respective holders of the information. Thereafter, within 15 days of receipt of the amount, the CDPO shall ensure providing of the information to the Appellant, by registered post.

With this, the Second Appeal Petition is disposed of.
