The petitioner is present.

The Public Authority is absent without any intimation.

In view of large number of cases pending before the Commission, the matter is taken up for hearing *ex parte*.

On perusal of case records, it appears that an RTI application was filed by Sri Abul Khayer Barbhuiya on 27.05.2016 addressed to the Asstt. Director of Food, Civil Supplies & Consumer Affairs, Hailakandi seeking for information on 6 (six) GPSS, namely, Rajyeswarpur GPSS Ltd., Mohanpur GPSS Ltd., Dholai Katlicherra GPSS Ltd., Matijuri GPSS Ltd., Algapur GPSS Ltd. and Monipur GPSS Ltd.. The petitioner also submitted his First Appeal on 26.10.2015 before the Asstt. Director of Food, Civil Supplies & Consumer Affairs, Hailakandi for furnishing of the information. The Asstt. Director vide letter dated 30.05.2015 and 03.12.2015 informed the petitioner that information sought for from the 6 (six) GPSS mentioned above would be provided after submission of receipt of the documents received by him from M/s.Dhonipur GPSS Ltd. on 30.04.2015.

The petitioner present stated that he had received the information on M/s Dhonipur GPSS Ltd. as he had filed a separate RTI petition on M/s Dhonipur GPSS Ltd. and on receipt of the same that matter was disposed of.

The Commission observes that the information sought for by the petitioner has not been furnished by the SPIO. The Asstt. Director of Food, Civil Supplies & Consumer Affairs, Hailakandi is directed to collect all the information sought for by the petitioner from the 6 (Six) GPSS mentioned in his RTI petition dated 27.05.2016 and furnish the same to the petitioner within 30 days from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 21.03.2016 stands disposed.
