The Joint Secretary to the Govt. of Assam & SPIO had submitted a written statement dated 05.07.2016 that the petitioner had already been furnished with the available information on 15.06.2015. She stated that the petitioner was not satisfied with the information furnished and filed an Appeal petition before the First Appellate Authority/Secretary to the Govt. of Assam, Guwahati Development Department on 03.08.2015. Hearing was fixed on 23.09.2015 and 09.10.2015 but the First Appellate Authority had to move out of station on Election Duty, the hearing could not be taken.

In view of the above, the Commission remands the matter to the First Appellate Authority i.e. Secretary to the Govt. of Assam, Guwahati Development Department for hearing and disposal of the First Appeal dated 03.08.2015 with a speaking order within 21 days from the date of receipt of this order. Hearing re-fixed on 08.08.2016 is cancelled.

With the above direction, the Second Appeal petition dated 06.01.2016 is disposed of. Inform all concerned.
