O R D E R

The petitioner Md. Lokman Ali is present. The public authority is represented by Smti. Deva Prova Kakoti, Child Development Project Officer (CDPO), Chamaria ICDS Project, Nagarbera, Dist. Kamrup (R). The second appeal petition dtd 31.3.14 is taken up for hearing in presence of both the parties.

The CDPO of Samaria ICDS Project has submitted a written statement dtd 8.7.16 along with enclosures. She has mentioned that her predecessor had written to the petitioner on 15.11.13 asking him to deposit Rs. 75,000.00 for furnishing the information sought for by the petitioner vide his RTI petition dtd 11.9.13. It is clear that the communication asking the petitioner to deposit the cost of furnishing the information was given after expiry of 30 days. The petitioner, it seems, did not contact the CDPO thereafter as stated in the WS dtd 8.7.16. In any case the position as it stands today is that the information sought for is voluminous, the petitioner has not deposited the amount sought for and no information has been furnished to the petitioner.

In view of the above, this Commission directs the CDPO, Chamaria ICDS Project to allow the petitioner to inspect the relevant records and documents during office hours on any working day within 15 days from the date of receipt of this order and also allow him to take notes and photocopies of required records and documents free of cost up to 100 pages and thereafter on payment of Rs. 2.00 for every additional page of photocopy.

With the above order, the second appeal petition dtd 31.3.14 is disposed of.
