ORDER

12.7.2016

The petitioner Shri Dulal Bora is absent without any information. The public authority is represented by Smti. Mayuri Chetia, ACS, Deputy Secretary to the Govt. of Assam & SPIO, Revenue & Disaster Management Department. The second appeal petition dtd 4.3.14 is taken up for hearing ex-parte in absence of the petitioner.

The SPIO and the Deputy Secretary, Govt. of Assam, Revenue & Disaster Management Department submitted a written statement dtd 12.7.16 stating that the then SPIO rejected the petitioner's RTI petition dtd 4.9.13 on the ground that by his RTI petition the petitioner asked some questions which need not be replied to in terms of the Central Information Commission's order dtd 21.4.06 in file No. CIC/80/A/2006/00045. The FAA has also submitted a separate written submission dtd 12.7.16, enclosing a copy of his order dtd 3.2.14 rejecting the petitioner's first appeal petition dtd 27.12.13 on the same ground.

From perusal of the case records it is seen that vide his RTI petition the petitioner has raised some questions without specifying the information which he wanted. From perusal of the RTI petition it is seen that the petitioner may get an appropriate reply to the question raised by him, if he specifies the relevant records/documents sought for by him. The petitioner is therefore, directed to file fresh RTI petition, if he is interested to do so, before the concerned authority, which in this case appears to be the Circle Officer of Sonapur Revenue Circle, specifying documents/information like copy of mutation order and copy of relevant Jamabandhi, Chita, etc., required by him.

With the above order, the second appeal petition dtd 4.3.14 is disposed of.
