O R D E R

The petitioner Sri Himangshu Choudhury is present accompanied by Advocate Sri Ajay Baruah. The public authority to be represented by the SPIO of Secretariat Administration (Nazarat) Department is absent without any information.

The second appeal petition dated 18-12-2015 is, therefore , taken up for hearing ex-parte in the absence of the concerned SPIO.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 12-8-2015. Some parts of the copy of the RTI petition which the petitioner submitted with his second appeal petition is not legible. The petitioner filled up the missing parts during the course of the hearing today.

The gist of his RTI petition is that in November, 2003 he had applied for appointment compassionate grounds following the death of his late father Anil Ch. Choudhury on 23-6-2013, who was a Gr.-IV (Peon) employee under SA (N) Department. The petitioner wants copies of his application form along with its enclosures. He also wants to know the present status of his application for appointment on compassionate grounds.

This Commission directs the SPIO of Secretariat Administration (Nazarat) Department to allow the petitioner to inspect the relevant records including the file notings processing his application and furnish him copies thereof along with his application form with all its enclosures during office hours on any working day within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 18-12-2015 is disposed of.
