**O R D E R**

The petitioner/ appellant Smti Gauri Maya Dey is absent without information. She was absent on the last two days of hearing i.e., 22-6-2016 and 5-7-2016 also. The public authority today is represented by Smti Esther Kathar, Additional Deputy Commissioner, Kamrup (Metro), Land Revenue (Land sale) branch in the office of the Deputy Commissioner, Kamrup (Metro).

The matter is taken up for review of compliance of this Commission's earlier order dated 5-7-2016 ex parte in the absence of the petitioner.

ADC Smti Kathar submitted that in spite of her best efforts and search of available records, the document relating to the land sale NOC proposal No. KRM/2/2002/766 dated 10-10-2002 could not be traced out and therefore, the documents sought for by the petitioner could not be furnished.

The Addl. Deputy Commissioner also submitted that she has already filed an FIR dated 19-7-2016 with the Officer-In-Charge of Panbazar Police Station, Guwahati, specifically mentioning the specific 12 Nos of missing case records including NOC No. KRM/2/2002/766 dated 10-10-2002, which is the subject matter of this second appeal case. The ADC has also furnished a copy of the FIR lodged with the Panbazar Police Station.

In view of the above action taken by the office of the Deputy Commissioner, Kamrup (Metro), as above, and due to the repeated absence of the petitioner for the 3<sup>rd</sup> consecutive time today, this Commission disposes of the second appeal petition dated 20-3-2014 with the direction to the Deputy Commissioner, Kamrup (Metro) to closely follow up the Police Investigation.
