**O R D E R**

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by :- (1) Sri P. K. Khound, SPIO & Joint Secretary, Health & F.W Department, Govt. of Assam, Dispur, Guwahati-6.

The second appeal petition dated 27-12-2014 is taken up for hearing ex-parte in the absence of the petitioner.

The SPIO and Joint Secretary, Health & F. W. Department submitted that the RTI petition dated 15-10-2013 by Sri Dulal Bora, the petitioner, before the Commissioner of Health and Family Welfare Department was transferred to the Principal BSC Nursing College, Dibrugarh vide Health Department's letter dated 28<sup>th</sup> October, 2013. Thereafter, vide letter dated 18<sup>th</sup> November, 2013, the Principal of BSC Nursing College, Dibrugarh wrote directly to the petitioner Sri Dulal Bora giving reply to his RTI application.

As regards BSC Nursing guidelines of Govt. of Assam, a copy of which was sought for by the petitioner vide his petition dated 15-10-2013, the SPIO of Health & Family Welfare Department had furnished the relevant information to the petitioner vide letter dated 4<sup>th</sup> January, 2014

The SPIO of Health & Family Welfare Department further deposed that after receipt of the First Appeal Petition dated 17-12-2013, the petitioner was asked to appear before the First Appellate Authority first on 30-1-2014 and again on 25-2-2014. The petitioner did not turn up for hearing of the First Appeal petition on both the dates.

In view of the above, the second appeal petition dated 27-1-2014 appears to be without any merit. Hence the same is disposed of.
