O R D E R 17.08.2016

The Appellant present.

The SPIO absent. However, he has sent a Written Statement dated 05.08.2016. A Written Statement dated 16.08.2016 also received from the FAA/DEEO, Cachar cum DMC, SSA, Cachar.

Perused the Written Statement from the SPIO. It has been submitted that the information sought for had been forwarded to the DMC, SSA, Cachar through a letter dated 03.05.2014 by his predecessor in response to a letter no. DMC/SSA/RTI/2014/2432 dated 31.03.2014 from the latter *i.e.* DMC, SSA, Cachar received on 05.04.2014. A copy of the letter providing the information has been enclosed with the W/S.

Perused the W/S from the FAA. It has been submitted that the copies of the BEEO's above mentioned letter had been endorsed to the Appellant followed by the furnishing of the remaining information by the DMC, Cachar through a letter dated 19.07.2014. A copy of the said letter has been enclosed with the W/S. It has also been added that on receipt of the hearing notice from the Commission another set of the information has been forwarded to the Appellant through a letter dated 12.08.2016.

On the above mentioned submissions by the SPIO and FAA having been shown to him, the Appellant submitted that he has not received any of the letters.

In view of the facts brought out above, the Commission hereby orders that should the Appellant not receive the latest communication from the FAA/DEEO, Cachar cum DMC, SSA, Cachar, namely, DMC(C)/SSA/RTI 2005(SUC)/Hearing Appeal dated 12.08.2016 by the time he receives a copy of this order, he shall write to the said authority informing about the non-receipt thereof, and within 7 days of receipt of the same, the said authority shall provide a copy of the said letter dated 12.08.2016 with the relevant enclosures to the Appellant by registered post, free of cost.

With this, the Second Appeal Petition is disposed of.
