The Appellant present.

The SPIO absent but has sent a Written Statement dated 22.08.2016 which is taken on case record.

Heard the Appellant. He submitted that he had been provided with the list of beneficiaries of electric motor for irrigation whose receipt he had acknowledged on 17.08.2016 but the same pertained to Golakganj and Agomoni Blocks which are not in South Salmara Mankachar, Hatsingimari Agricultural Sub-Division. He further submitted that the information he had sought in point no. (ii) of his RTI Application, namely, beneficiaries of the facility of boring has been provided.

Perused the W/S. It has been submitted that the information has been provided and the same was acknowledged by the Applicant.

The submission of the Appellant that the beneficiaries list provided to him was not the information he wanted pertaining to the Agriculture Sub-Division is borne out by the record submitted by the SPIO with the W/S.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the Executive Engineer, Gauripur Agricultural Sub-Division, Dhubri shall provide the information sought for by the Appellant through his RTI Application dated 23.10.2013, free of cost, within 10 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
