The Public Authority is represented by Sri Manomohan Majumdar, SPIO (Inspector), Office of the Assistant Director, Food, Civil Supplies & Consumer Affairs, Hamren accompanied by Sri Lakshi Kanta Thakuria, SPIO/Secretary, Hamren Wholesale Consumer's Cooperative Society Limited, Karbi Anglong.

The SPIO, Office of the Assistant Director, FCS & CA has submitted a written statement dated 26.08.2016 stated that the information sought for by the petitioner was furnished by the Secretary, Hamren Wholesale Cooperative Societies Limited vide letter dated 30.08.2016.

The Secretary, Hamren Wholesale Consumer's Cooperative Society Limited present stated that vide letter dated 30.07.2016 he had informed the petitioner to deposit an amount of RS.6, 720/- as the cost of photocopying of documents sought for by him and that the actual amount would be calculated and adjusted at the time of delivery of the documents and excess amount would be returned but the petitioner did not get back to the office.

Since the petitioner is absent without any intimation, no hearing could be taken, the Commission observes that he is no longer interested to receive the information. Hence, the Second Appeal petition dated 11.02.2015 is disposed of.
