The petitioner Sri Indra Rongphar is absent without any intimation.

Sri Harol D Sangma, Sr. Asstt, office of the BDO, Bokajan Development Block stated that he was directed to attend the hearing as the BDO was on leave. He has submitted a copy of the letter dated 26.03.2015 furnishing the list of schemes to the petitioner implemented under the award of 13th Finance Commission for the year 2010-11 to 2013-14 and informed that fund of the year 2014-15 was not received. As regards Master Roll and Bill Vouchers, he has informed the petitioner to personally inspect the records available in the office of the BDO during office hours with prior of two days notice but the petitioner did not take up the matter with the authorities concerned.

The BDO, Longsomepi Development Block is represented by Sri Mohiram Inghi, Accountant. He has also stated that the information was furnished to the petitioner vide letter no. LMDB/13thFC/2015/16/28 dated 22.07.2016 through speed post.

In view of the absence of the petitioner, it could not be ascertained whether the information furnished was received by him. It also appears that the petitioner failed to contact the Public Authority i.e. BDO, Bokajan development Block to personally inspect the records available in the office as directed. The petitioner has also failed to appear today before the Commission without any intimation. Therefore, it appears that he is not interested to receive the information.

In view of the above, the Complaint petition dated 27.03.2015 is disposed of.
