Written statement dated 23.08.2016 has been received from the SPIO & Under Secretary to the Govt. of Assam, Hill Areas Department, Dispur.

The Public Authority is represented by Sri Kailash Ch. Lahkar, Addl. Chief Engineer, Irrigation, Zone- IV, Diphu. He has submitted a written statement dated 19.08.2016 that the documents relating to 36 MI schemes implemented in 2012-13 and 50 MI schemes implemented in 2013-14 cannot be furnished as the documents were destroyed by a fire on 03.08.2013 and FIR was lodged in Diphu Police Station vide letter dated 12.08.2013 which has been enclosed. He has also stated that documents relating to 60 nos. of MI schemes for 2013-14 had been submitted to the standing council in connection with PIL Case No. 107/2015 in the Hon'ble Guwahati High Court.

Since the matter is sub-judice, the Public Authority will take necessary action after the disposal of the PIL case no. 107/2015.

With the above direction, the Complaint petition dated 30.07.2015 is disposed of.
