## ORDER 23.08.2016

The petitioner Sri Indra Rongphar is absent without any intimation.

The Public Authority is represented by Ms. Chandrani Borkotoky, State Consultant & SPIO, office of the MD, RMSA, Assam. A written statement dated 20.08.2016 has been submitted by the Officer on Special Duty, RMSA cum First Appellate Authority that the RTI petition of Sri Indra Rongphar was received on 26.11.2014 seeking for information regarding Model School and Girls' Hostel of Karbi Anglong. The petitioner was directed to deposit the requisite fees vide letter dated 20.12.2014 but the same was not deposited by the petitioner. The petitioner filed another RTI petition seeking the same information along with some additional information which was received on 06.01.2016 and forwarded to the Principal Secretary, KAAC. Accordingly, the petitioner received the documents from the office of the DPC, Karbi Anglong after depositing the Requisite fees on 29.06.2016.

Since the petitioner is absent, it could not be ascertained whether he had received the documents he had sought for. However, since the information had been furnished to the petitioner as stated by the Public Authority and the petitioner is absent without any intimation, the Commission is of the view that the petitioner is no longer interested to receive the information, hence, the Second Appeal petition dated 16.03.2015 is disposed of.
