The petitioner Shri Ninush Dhan as well as the public authority to be represented by the Secretary of Timona Gaon Panchayat, Lahowal; Dist. Dibrugarh – both are absent. Shri Utpol Gogoi, Secretary of Timona Gaon Panchayat has sent a written submission dated 20.8.16 stating that required information was already furnished to the petitioner. However, from perusal of the enclosed papers it is seen that the same petitioner was furnished with required information to his satisfaction against his RTI petition dated 4.11.13 filed before the Project Director, DRDA, Dibrugarh, against which a second appeal petition dated 17.1.14 was disposed of by this Commission by an order dated 16.3.16 in case No. DBR.9/2014. The instant Case No. DBR.8/2014 relates to the same appellant against his second appeal petition dated 17.1.14 with reference to RTI petition dated 29.10.13 filed before the SPIO of Timona GP. It is seen that the contents of the two RTI petitions are also different.

However, in absence of both the parties, the instant second appeal petition dtd 17.1.14 could not be heard. Nor have the petitioner and the appellant submitted any prayer for deferment of the hearing.

In view of the above, this Commission directs the Secretary of Timona GP, Lahowal, Dist. Dibrugarh to allow the petitioner, if he has not already received the sought for information and is still interested in receiving the same, to inspect relevant records and documents during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of sought for documents free of cost up to 20 copies and thereafter on payment of Rs. 2.00 for every additional page of photocopy.

With the above order, the second appeal petition dated 17.1.14 is disposed.
