O R D E R 05.9.2016

The petitioner Shri Dwarka Prasad Agarwal is absent. The public authority is represented by :- (1) Syed Isfaqur Rahman, Addl. Commissioner & SPIO, GMC, (2) Shri Santanu Das, AP, GMC, and (3) Shri Nabojyoti Bardoloi, ZE, GMC. The complaint petition dated 14.5.15 is taken up for hearing ex-parte in absence of the petitioner. The PIO of Guwhati Municipal Corporation has made a written submission dated 2.9.2016, which is entered into the case records.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 30.8.14 before PIO of Guwahati Municipal corporation seeking certain information on building construction on a plot of land measuring 1 bigha 4 katha and 16 lechas covered by dag no. 747, KP No. 225 of Sahar Guwahati Pt.II, Mouza- Guwahati under the ward no. 29 of GMC at Tokobari Kalimandir Road. The Collector & PIO of GMC vide letter dated 9.10.14 informed the petitioner that without the name of owner of the building, and ward number required record could not be traced out. Thereafter the petitioner filed first appeal petition dated 8.10.14, which was heard and disposed of by a speaking order dated 10.11.14 directing the petitioner/appellant to submit further details to facilitate furnishing of the sought for information.

From the case records it is seen that the petitioner furnished the required information to the GMC authority vide letter dated 31.9.14. Getting no response thereafter from the SPIO, the petitioner filed complaint petition dated 14.5.15.But in the absence of the petitioner or his authorized representative he could not be heard.
