O R D E R

The petitioner Shri Muhiteswar Goswami is present accompanied by one Shri Rantu Baishya to assist him. The public authority is represented by Shri Dilip Kr. Baruah, Sr. Assistant of the office of the Joint Director of Health Services, Kamrup, Amingaon. The second appeal petition dtd 11.12.14 is taken up for hearing in presence of both the parties.

I/C, Sub-Divisional Medical & Health Officer, North Guwahati PHC is absent. But he has sent a written submission dtd 18.8.16, which is entered into the case records. In his WS it has been stated that after his RTI petition dtd. 10.12.13, the petitioner filed another RTI application dtd 20.2.14 seeking some additional information. After compiling required information, the SDM&HO, i/c wrote to the petitioner on 6.9.14 to collect the required information on 9.9.14. However, when the petitioner arrived to collect the information, information was not furnished to him on the ground of ailment of one Shri Ashok Kr. Kalita, an employee of the office, as has been given in writing by the SDM&HO himself under his seal and signature. The SPIO stated that the petitioner could collect the required information during office hours.

This Commission observes that the petitioner filed his second appeal petition before this Commission on 11.12.14 i.e ten months after filing the first appeal petition, which is time barred. However, since the SDM&HO mentioned that the sought for information is ready with him, this Commission directs the petitioner to collect the same from the office of the SDM&HO, North Guwahati Block PHC, Guwahati-31 within 15 days from the date of receipt of this order.

With the above order, the matter is disposed of.
