The complaint petition dated 10-4-2015 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner Sri D.Gogoi filed an RTI petition dated 30-12-2014 before the BDO, Lakhimpur Development Block, District-Lakhimpur seeking information about names, Addresses of beneficiaries under IAY and old age pension schemes along with amount of funds received, sanctioned and released against each beneficiary those two Schemes for the years 2013-2014,

He filed a complaint petition dated 10-4-2015 before this Commission after he did not get any response from the BDO, Lakhimpur. The petitioner, however, stated that he is still interested in getting the sought for information and made a written prayer for conversion of his complaint petition dated 10-4-2015 into an appeal petition under Section 19 of the RTI Act, 2005. His prayer is granted and this Commission directs the BDO, Lakhimpur, who is present today to furnish the required information from the BDO, Lakhimpur, who has come prepared with all the information sought for to the petitioner. The BDO, Lakhimpur handed over the same to the petitioner in presence of this Commission today.

The BDO, Lakhimpur, further submitted that such informations are available on-line in the website- iay.mc.in of the block office since 2013.

In view of the above, this complaint/ appeal petition dated 10-4-2015 is disposed of.
