**O R D E R**

The SPIO-cum-SDAO, Horticulture in the office of the District Agriculture Officer, Kamrup District Sri Rabindra Sarmah is present. The petitioner/ appellant Md. Ataur Rahman is also present

The matter is taken up for review of compliance of this Commission's earlier order dated 14-6-2016.

The SPIO made a written submission dated 22-7-2016. In his written submission he stated that on 20-7-2016 the petitioner came to his office, as requested, but refused to accept the NVIUC beneficiary list. The petitioner wanted copies of the detailed APRs also.

After hearing both the parties, the Commission directs the SPIO to hand over attested copies of the beneficiary list and amount of funds released as per requirement, mentioned by the petitioner in his RTI petition dated 22-7-2014. The SPIO is directed to hand over the above information, duly attested to the petitioner within 7 days from the date of receipt of this order.

As regards copies of APRs, the petitioner may file a separate RTI petition before the SPIO of the office of the DAO, -Kamrup District, because APRs were not mentioned in his RTI petition dated 22-7-2015.

As regards the show cause reply dated 22-7-2016 the SPIO has stated the reasons for the delay in furnishing the information sought for by the petitioner. Being the first time lapse, the SPIO is warned to be more careful in dealing with RTI matters in future.

With the above orders the complaint petition dated 8-10-2015, which was converted into a second appeal petition, is hereby disposed of.
