ORDER

The petitioner Smti Trishna Goswami is present accompanied by her husband Sri Parag Goswami. The public authority is represented by :- (1) Dr. Avijit Basu, Joint Director, DHS (H.Q), of the office of Directorate of Health Services, Assam, Hengrabari, Guwahati-36, (2) Sri Dilip Kr. Borah, Jr. Assistant of the same office, and (3) Sri Bijoy Sarma, Jr. Assistant of the same office.

The second appeal petition dated 30-6-2015 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner by her RTI petition dated 6-4-2015 sought information regarding the selection process including marks secured by different category of candidates in the written and oral tests for filling up the post of Surveillance Workers (Malaria) in Nagaon and Morigaon districts with reference to advertisement No. HSE/HE/37/2013/20302 dated 9-12-2013. It is seen that all the informations sought for by her are admissible under the RTI Act, 2005, but voluminous in nature. In such cases it is advisable that the public authority informs the petitioner within the stipulated period of 30 days to inspect the relevant records and gives him/her reasonable number of photocopies of documents sought for by her/him

However, the Joint Director, Health Services have already brought photocopies of the voluminous documents for furnishing them to the petitioner after receiving notice from this Commission.

This Commission, therefore, directs the Joint Director of Health Services to hand over the documents to the petitioner, free of cost , as the prescribed time period for furnishing the reply is already over.

With the above order the second appeal petition dated 30-6-2015 is disposed of.
