**O R D E R**

The petitioner Sri U. K. Mishra is absent without any information. The public authority i.e., GMC is represented by:- (1) Sayed Isfaque Rahman, SPIO and Additional Commissioner, GMC, (2) Smti Archana Konwar, Zonal Engineer, GMC, and Sri P. Rajesh Singh, attached to SPIO, GMC.

From perusal of the case records, it is seen that the petitioner Sri U. K. Mishra filed an RTI petition dated 25-3-2014 before the PIO of the office of the Commissioner of GMC seeking information about construction plan, letter of approval for construction and No Objection Certificate for construction by Assam Bengal Carriers India Ltd. at Beharbari, Guwahati.

However, it is seen that the First Appeal petition dated 19-5-2014 and his second appeal petition dated 24-9-2014 were signed by one Sri Jitendra Pandey and one Sri Arun Ghosh claiming to be the authorized representative of the petitioner but without any letter of authority from the petitioner Sri U. K. Mishra.

This Commission, therefore, could not entertain the second appeal petition signed by one Sri Arun Ghosh, claiming to be the authorized representative of the petitioner Sri U. K. Mishra without any supporting authority letter.

Today this Commission dealt with another second appeal Case No. SIC/KP(M).409/2016 containing another second appeal petition dated 8-8-2016 with reference to an identical RTI petition dated 2-4-2014 filed by the same petitioner Sri U. K. Mishra before the GMDA Authorities.

In the absence of the petitioner Sri U. K. Mishra or Sri A. Ghosh, claiming to be authorized representative of the petitioner, they could not be heard

In any case, the PIO of GMC submitted before this Commission a copy of their letter dated. 4-8-2014 addressed to Sri U. K. Mishra, the petitioner, informing him that as per computerized data base, no record of building permission was found in the name of ABC India Ltd or M/S Assam Bengal Carriers Ltd.

However, the petitioner in his RTI petition mentioned the Assessment ID No. given by GMC in respect of the property mentioned in the RTI petition.

This Commission, therefore, directs the SPIO of GMC to ascertain from GMDA and verify from the Assessment I.D No. whether the corresponding property belongs to some other party of which M/S Assam Bengal Carriers Ltd. or ABC India Ltd. may be a lessee or a tenant. If it is so, then the SPIO of GMC is directed to inform the petitioner about the position so that the petitioner may file fresh RTI petition, if he so chooses.

With the above order the matter is disposed of.
