## ORDER

19.8.2016

The petitioner Md. Jiauddin Ahmed is absent without information. The public authority is represented by by:- (1) Shri P.K. Hazarika, Director, Horticulture, Assam and (2) Shri Samiran Bardoloi, Research Assistant of the Directorate of Horticulture, Assam. The second appeal petition dtd 12.1.16 is taken up for hearing ex-parte in absence of the petitioner.

The petitioner has sent written submission dtd 16.8.16 stating that due to illness he is unable to attend the hearing today. He also mentioned that the Director of Horticulture has provided him some information, but correct and complete information in respect of query no. 4,5,6,7,8,9,11,13 & 17 have not been provided to him so far.

However, it is also seen from the case records that the SPIO and Jt. Director of Horticulture vide his letter dtd 18.1.16 furnished several information with enclosures to the petitioner. The petitioner is not specific as to which part of the information received is incorrect and incomplete. In his absence he could not be heard.

This Commission, therefore, directs the SPIO of the Directorate of Horticulture, Govt. of Assam to allow the petitioner to inspect relevant records and documents during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of admissible documents free of cost up to 20 pages and thereafter on payment of Rs. 2.00 for every additional page of photocopy.

With the above order, the second appeal petition dtd 12.1.16 is disposed of.
