O R D E R 16.09.2016

The SPIO absent. However, Written Statements dated 09.09.2016 and 12.09.2016 have been received from the First Appellate Authority/Asstt. Registrar of Co-operative Societies, Karimganj and the SPIO respectively.

The Appellant present.

Perused the W/S from the FAA. It has been submitted that the First Appeal had been disposed of with a direction to the SPIO/Secretary, Kaliganj Co-operative Society Ltd. to keep the information ready to be delivered to the Applicant as when he would visit the office.

Perused the W/S from the SPIO. It has been submitted that the information has been furnished to the Appellant through a letter dated 10.09.2016 by registered post with A/D after receiving the Commission's hearing notice. Apology has been offered for his failure to provide the information in time. The SPIO has however not given any evidence relating to the dispatch of the letter by registered post. It is also seen that although a copy of the said letter dated 10.09.2016 has been enclosed, no copy of the Deputy Commissioner (F.C.S. & C.A.) order no. KSG.5/2000/94 dated 30.12.2010 has been enclosed although it is stated to have been enclosed.

Heard the Appellant. He submitted that he has not received the information stated to have been sent to him by the SPIO through a letter dated 10.09.2016.

From the above, the Commission observes that it is possible that the said letter dated 10.09.2016 through which the SPIO has provided the information to the Appellant is still in transit and due to be delivered to the addressee, *i.e.* the Appellant. The Commission therefore hereby orders that should the Appellant not receive the said letter in the next 5 - 6 days, he shall inform the SPIO in writing about it, and the SPIO shall send another copy of the letter containing the information/documents to the Appellant by registered post, free of cost, within 7 days of receipt of such communication from the Appellant. While sending the information/documents, the SPIO shall ensure that a copy of the aforementioned order of the D.C. (F.C.S. & C.A.) dated 30.12.2010 is enclosed.

With this, the Second Appeal Petition is disposed of.
