The Public Authority is represented by Shri K.J. Hilaly, representative of the First Appellate Authority/S.O. to the Chief Secretary, Assam along with Shri Manjit Kr. Das, Sr. Research Officer, Finance (E.A.) Department and Shri Abhijit Dutta, Research Officer of the same office. A Written Statement dated 05.09.2016 received from the Joint Director, Finance (Eco. Affairs) Department, Assam which is taken on the case record.

The Appellant present.

Perused the W/S. It has been submitted that the documents relating to the information sought for by the Appellant have since been provided to him and that the delay in furnishing the information was on account of misplacement of the RTI Application.

Heard the Appellant. He submitted that he has indeed received the documents relating to the information he had sought for but was not satisfied with the documents provided in connection with point no. 3 of his Application. He also submitted that the information provided in connection with this point related to another RTI Application he had submitted.

Perusal of the RTI Application of the Appellant indicates that point no. 3 therein is not clearly worded.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall write to the SPIO clarifying/specifying the information that he had sought through point no. 3 of his RTI Application dated 31.10.2013, within 7 days of receipt of this order, and the SPIO shall provide the information, within 10 days of receipt of the said communication from the Appellant.

With this, the Second Appeal Petition is disposed of.
