The petitioner, Sri Jawaharlal Narzary is present.

The Public Authority to be represented by SPIO, office of the Addl. Principal Chief Conservator, Forests, KAAC, Diphu is absent without any intimation. In view of the large number of cases pending before Commission, the matter is taken up ex-parte.

On perusal of the records, it appears that the RTI application was filed by Sri Jawaharlal Narzary on 21.12.2015 seeking information regarding the CAMPA Scheme/Works executed by the D.F.O, Karbi Anglong East Division, Karbi Anglong West Division, Dhansiri Division and Hamren Division for the period of 2010 till date of filing of RTI Application.

The petitioner had filed his First Appeal before the PIO, Office of the Addl. Principal Chief Conservator of Forests, KAAC, Diphu on 03.02.2016, since no responses have been received on his RTI Application. He had filed Second Appeal before the Commission on 27.05.2016 due to non-receipt of information and non-disposal of First Appeal dated 03.02.2016.

In view of the above, the Commission directs the Asstt. Public Information Officer, Office of the Addl. Principal Chief Conservator of Forests, Karbi Anglong Autonomous Council, Diphu to furnish information to the petitioner within 15 days from receipt of this order.

With the above directions, the Second Appeal dated 27.05.2016 is disposed of.
