**O R D E R**

The petitioner, Shri Jawahorlal Narzary is absent without any intimation.

The Public Authority to be represented by SPIO, Office of the Addl. Chief Conservator of Forests Karbi Anglong Autonomous Council, Diphu is also absent without any intimation.

In view of the absence of both the parties, no hearing could be taken and the case is taken up based on records.

On perusal of the record, it appears that the petitioner Shri Jawahorlal Narzary had filed a RTI application dated 21.12.2015 seeking information regarding the CAMPA Scheme executed by the D.F.O. Karbi Anglong East Division/Karbi Anglong West Division/Dhansiri Division and Hamren Division. He had filed first appeal petition addressed to the APIO, Office of the Addl. Chief Conservator of Forests Karbi Anglong Autonomous Council, Diphu as no reply has been received on his RTI Application dated 21.12.2015. The petitioner had filed Second Appeal before the Commission as he did not receive any information on his RTI application dated 21.12.2015 and First Appeal dated 03.03.2016.

In view of the absence of the petitioner, it cannot be ascertained whether information sought for has been furnished to him by the Public Authority concerned.

The Commission, therefore, directs the Public Authority, the SPIO, Office of the Addl. Chief Conservator of Forests Karbi Anglong Autonomous Council, Diphu to furnish information to the petitioner within 21 days from receipt of this order, if not furnished earlier.

Further the Commission hereby orders that the First Appellate Authority, Additional Principal Chief Conservator of Forests, Karbi Anglong shall consider and dispose the 1<sup>st</sup> Appeal petition dated 03.03.2016 with a speaking order within one month from the date of receipt of this order.

With the above directions, Second Appeal dated 27.05.2016 is disposed of.
