The petitioner Shri Indra Rongphar is absent but has submitted a written statement dated 18.07.2016 that he had not received the information sought for vide his RTI petition dated 27.11.2013 till date from the SPIO, office of the Executive Engineer, PWD, Kohora Road Division, Karbi Anglong. He also informed that he will not be able to attend the hearing today.

The Public Authority is absent without any intimation.

In view of large number of cases pending before the Commission, the matter is taken up for consideration based on records.

On perusal of records, it appears that the petitioner was directed by the Executive Engineer, PWD, Kohora Road Division, Dolamara vide letter dated 25.02.2014 to deposit an amount of Rs. 200/- for preparation of RTI documents. The petitioner vide letter dated 07.03.2014 had informed the Executive Engineer, Kohora Road Division that the same amount of Rs. 200/- was deposited in the form of SBI demand Draft. Since, he was not furnished with the information even after the payment of the required amount for furnishing the information he filed a Complaint petition before the Commission on 23.06.2014.

In view of the above, the Commission directs the SPIO, office of the Executive Engineer, PWD, Kohora Road Division, Dolamara to furnish the information within 15 days from the date of receipt of this order.

With the above direction, the Complaint petition dated 23.06.2014 is disposed of. The petitioner shall be at liberty to submit a complaint of non-compliance in case he is not satisfied with the action taken by the SPIO in accordance with this order.
