The SPIO is represented by Sri Ganesh Choudhury, Asstt. Director, Food, Civil Supplies & Consumer Affairs (FCS & CA), Hailakandi.

Heard the Asstt. Director, FCS & CA, Hailakandi. He submitted that the Appellant had collected the information relating to Matijuri GPSS ltd. and had acknowledged receipt through a letter dated 16.07.2016. A copy of the acknowledgement has been submitted to the Commission as evidence. He added that the Appellant had been informed in writing to collect from his office the information relating to Algapur GPSS ltd. and that the Appellant collected the said letter but not the information.

A perusal of the RTI Application of the Appellant indicates that he had addressed the Application to the Secretaries of the two GPSS ltd. of Algapur and Matijuri.

In view of the facts brought out above, the Commission hereby observes that the Public Authority is ready with the information to be provided to the Appellant. It is therefore hereby ordered that the Asstt. Director, Food, Civil Supplies & Consumer Affairs, Hailakandi shall send the information to the Appellant by registered post, within 10 days of receipt of this order, free of cost.
