The petitioner Srimati Samiun Nessa is absent without any information. The public authority is represented by :- (1) Smti Jyotsna Medhi Patgiri, ACS, Additional Deputy Commissioner and SPIO , Kamrup (Metro), and (2) Smti Suswapna Kakoti, ACS, Circle Officer (Attached), Guwahati.

The second appeal petition dated 25-3-2014 is taken up for further hearing in pursuance of this Commission's earlier orders dated 17-6-2016 and 17-8-2016. The Circle Officer, Guwahati Revenue Circle has sent a copy of his letter dated 14-9-2016 addressed to Smti S. Nessa, the petitioner, informing her that the relevant records relating to Misc. Case No. 35/2005/2006 has been found and kept ready for handing over to the petitioner. Smti Samiun Nessa was also informed by the Circle Officer to collect the required information from the Circle Office. The Circle Officer (Attached) informed today that the petitioner was also informed telephonically to collect the required materials and the petitioner informed the Circle Office that she will go to collect the required information after the Eid festival.
