**O R D E R**

The petitioner Sri Bijoy Das is present. The public authority to be represented by the BDO of Telahi Development Block, Lakhimpur is absent without any information.

The petitioner's complaint petition dated 9-6-2015 read with his RTI petition dated 13-2-2015 is taken up for hearing ex parte in the absence of the BDO, Telahi development block, Lakhimpur.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 13-2-2015 before the BDO, Telahi development block , Lakhimpur, seeking names of the beneficiaries under Indira Awas Yojana of Pub Telahi G.P and Lohit Khablu G.P under Telahi development block for the financial years 2013-14 and 2014-15. He also wanted the names of the concerned G.Ps who selected the beneficiaries.

This Commission is of the view that both the above informations are admissible under the RTI Act, 2005. By his third query the petitioner lodged a complaint regarding use of tractors in place of labour in implementation of MGNREGA schemes. This Commission is not competent to address such complaints for which the petitioner may approach the competent disciplinary or Vigilance authorities.

When asked by this Commission, the petitioner deposed that he is still interested in getting the informations sought for by him vide his RTI petition dated 13-2-2015. Accordingly he made a written submission praying for conversion of his complaint petition dated 9-6-2015 into a second appeal petition. His prayer is granted and the BDO, Telahi development block, District- Lakhimpur, North Lakhimpur is directed to furnish the first two informations mentioned above, which are admissible under the RTI Act, 2005 to the petitioner, free of cost, within 15 days from the date of receipt of this order and report compliance.

With the above order the complaint/ second appeal petition dated 9-6-2015 is disposed of.
