O R D E R

The petitioner Smti Pankaja Buragohain is absent without any information. The public authority is represented by:- (1) Sri Pranab Kr. Borah, General Manager & 1st Appellate Authority, DICC, Kamrup (Metro), Bamunimaidam, Industrial Estate , and (2) Sri Dhireswar Kachar, Functional Manager, SPIO of the same office.

The second appeal petition dated 9-4-2014 is taken up for hearing ex parte in the absence of the petitioner.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 17-1-2014 before the SPIO of DICC, Industrial Estate, Guwahati seeking various informations about M/S Progressive Fertichem Pvt. Ltd, situated at Topatoli, District- Kamrup (M). She wanted to know whether any fertilizer Company of Assam can claim/ avail both transport subsidy and fertilizer subsidy at the same time and she sought copies of unit affidavits and transporter/ carrier affidavits submitted by M/s Progressive Fertilizers Pvt. Ltd., besides several other informations.

The SPIO and Personnel Manager of DICC has submitted a written statement dated 6-9-2016 stating that the required information was furnished to the petitioner vide DICC letter dated 11-02-2014 . Subsequently, in response to the petitioner's first appeal petition dated 27-2-2014, the GM, DIC also wrote to the petitioner vide letter dated 10-3-2014 that the required information was already furnished to her and requested her to visit the G.M's office for further information. The letter dated 10-3-2014 also has a mention that the petitioner was contacted over telephone also.

The SPIO submitted in course of today's' deliberations that the petitioner did not turn up nor did she make any further communication with the DICC.

In view of the above, there does not seem to be any further cause of action before this Commission. The second appeal petition dated 9-4-2014 is therefore, disposed of with the direction to the G.M, DIC to allow the petitioner , if she still wants to , to inspect the relevant records and documents with reference to her RTI petition dated 11-1-2014 and her first appeal petition dated 27-2-2014 within 15 days from the date of receipt of this order.
