The Public Authority is represented by Smti. Karuna Das, SPIO, DICC, Golaghat and Shri Jamson Terang, D. A., DICC, Golaghat. A Written Statement dated 20.09.2016 has been received from the First Appellate Authority/General Manager along with an enclosure.

The Appellant present with her authorised assistant.

Perused the W/S including its enclosure. It is seen that a common W/S has been submitted in respect of the 7 (seven) Second Appeal cases, namely SIC/GLT.67/2016, SIC/GLT.69/2016, SIC/GLT.70/2016, SIC/GLT.71/2016, SIC/GLT.72/2016, SIC/GLT.73/2016, SIC/GLT.76/2016 filed by the same Appellant.

Perused all the Second Appeal cases and heard the Appellant as well as the SPIO. It is seen that the 7 (seven) RTI Applications which were submitted on different dates to the SPIO by the Appellant pertain to various information relating to broadly the same subject. The Commission therefore has decided to pass a single order covering all the said Appeal cases as follows –

1. SIC/GLT.67/2016

In respect of point no. 2 of the RTI Application dated 21.07.2015 the report of the committee to conduct viva has only been provided. The SPIO shall furnish a certified copy of the panel drawn up by the office of the DICC, Golaghat based on the recommendation of the selection committee.

2. SIC/GLT.69/2016

A. In respect of the information sought through point no. 3 of the RTI Application dated 13.07.2015 only a newspaper advertisement regarding vacancies had been provided to the Appellant whereas the information sought for pertained to the number of committees/sub-committees constituted and the member thereof. The SPIO shall provide the information as sought for.

B. Information sought for through point no. 4 and 5 as also through RTI Application dated 06.07.2015/ SIC/GLT.72/2016 shall be provided with the relevant documents.

C. The SPIO shall furnish the specific dates on which the notification on appointment has been dispatch to the members of the selection committee.

3. SIC/GLT.70/2016

The SPIO shall furnish a certified copy of the written communication made to the bank approving/recommending PMEGP loan in favour of the person concerned, namely Shri Ballav Jyoti Bori sought through the RTI Application dated 01.07.2015

4. SIC/GLT.71/2016

The SPIO shall provide the remaining information sought through point no. a) and b) of the RTI Application dated 01.07.2015, namely copies of the answer books for the written test and the computer typing test.

5. SIC/GLT.72/2016

No specific information has been provided as sought for through the RTI Application dated 06.07.2015. The SPIO shall provide the specific information relating to all the 3 (three) queries which pertained to departmental guidelines for constitution of selection committee for selection of candidates for filling vacancies, the constitution of the committees/sub-committees and the minutes/resolution of the meetings of such committees/sub-committees. This information was sought through the RTI Application dated 13.07.2015 as mentioned above.

6. SIC/GLT.73/2016

The SPIO shall furnish a certified copy of the appointment letter issued to the selected candidates sought through the RTI Application dated 03.07.2015.

7. SIC/GLT.76/2016

Partial information has been provided in respect of point no. b) of the RTI Application dated 03.07.2015. The SPIO shall provide the information in the form of notification etc. relating to the constitution of the selection committee containing the names of the members who were entrusted with the responsibility of entire selection process for filling up two vacant posts of Junior Assistant in the office of the District Industries and Commerce Centre, Golaghat.

The information shall be provided by the SPIO to the Appellant, free of cost, in accordance with this order, within 10 days of receipt thereof.

In view of the above, the said 7 (seven) Second Appeal cases are hereby disposed of.
