The petitioner Sri A.K. Laskar is absent, but has intimated that he has not received any information sought for. He has also informed that he would not attend the hearing as his son has been hospitalized.

The Public Authority is absent, but Block Development Officer, Sonai Development Block has submitted a written statement dated 19.09.2016 that RTI petition dated 08.01.2014 was not available as per record of Block office. He also stated that various RTI petitions were filed dated 06.02.2012, 21.10.2008, 08.05.2007 etc. and information sought for had been furnished to the petitioner. He further stated that even though original RTI Application submitted by Sri A.K. Laskar on 08.01.2014 was not received, he was ready to supply the information sought for within stipulated time.

The Commission, therefore, directs the petitioner to inspect relevant office record in the office of Block Development Officer, Sonai Development Block and respective Goan Panchayat Secretaries within 15 days from the date of receipt of this order.

The Block Development Officer, Sonai Development Block, Cachar and Goan Panchayat Secretaries are also directed to allow the petitioner to inspect relevant documents and allow him to take notes and photocopy of sought for documents, free of cost, upto 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above directions, the Complaint Petition dated 02.06.2014 is disposed of.
